

PROMOTION TERMS AND CONDITIONS

“BUY 1 GET 1 FREE – INPROGRESS+”

§ 1

General Provisions

1. These Terms and Conditions define the rules of the “Buy 1 Get 1 Free – Inprogress+” promotion (hereinafter: the “Promotion”).
2. The Promotion applies to the Inprogress+ Subscription service offered by INPROGRESS Sp. z o.o. (Tax ID: 6772357001, KRS: 0000384161) and INPROGRESS Szkolenia Sp. z o.o. (Tax ID: 6772369990, KRS: 0000427134) (hereinafter jointly referred to as “INPROGRESS”).
3. Information on which entity referred to in section 2 is the party to a given agreement shall be provided to the Customer prior to the conclusion of the contract for training services.
4. Matters not regulated herein shall be governed by the Terms and Conditions of Service available at www.inprogress.pl.

§ 2

Duration of the Promotion

1. The Promotion is valid from April 7, 2026, until the pool of free Inprogress+ Subscription is exhausted.
2. INPROGRESS reserves the right to terminate the Promotion earlier in the event that the pool is exhausted.
3. The availability of the Promotion is determined by the order of paid Orders.

§ 3

Promotion Rules

1. The Promotion consists in granting the Customer a one-time discount code reducing the cost of a second Inprogress+ Subscription to 0 PLN.
2. To qualify for the Promotion, the Customer must:
 - a) place an Order for an Inprogress+ Subscription for 6 or 12 months,
 - b) make payment for the Order.
3. The discount code is granted after the payment has been credited to the INPROGRESS bank account.
4. If payment for the Order is not made within 14 days from the date of placing the Order, INPROGRESS may cancel the Order, and any rights related to participation in the Promotion shall expire.

§ 4

Scope of the Promotion

1. The Promotion applies to Inprogress+ Subscriptions:
 - a) for 6 months,
 - b) for 12 months,available in Polish and English language versions.
2. Under the Promotion:
 - a) when purchasing a 12-month Inprogress+ Subscription – the Customer is entitled to one free Inprogress+ Subscription for 12 months or 6 months, in Polish or English,
 - b) when purchasing a 6-month Inprogress+ Subscription – the Customer is entitled to one free Inprogress+ Subscription for 6 months, in Polish or English.

The language of the free Inprogress+ Subscription may differ from the language of the purchased and paid Subscription.

3. It is not possible to divide one free Subscription into multiple shorter periods for different Participants.
4. INPROGRESS reserves the right to limit the availability of Subscriptions covered by the Promotion with respect to selected language versions, in particular to discontinue the sale of the Polish version while maintaining the availability of the English version.

§ 5

Customers

1. The Promotion is addressed to:
 - a) consumers within the meaning of Article 22¹ of the Polish Civil Code,
 - b) entrepreneurs, i.e. entities that are not consumers within the meaning of Article 22¹ of the Polish Civil Code,
 - c) entities financing services in at least 70% from public funds referred to in Article 5(1) of the Public Finance Act.
2. The Promotion is available to both new and existing INPROGRESS customers.

§ 6

Use of the Discount Code

1. The discount code:
 - a) is valid for 14 days from the date of receipt,
 - b) is for one-time use only,
 - c) cannot be exchanged for cash.
2. To use the free Inprogress+ Subscription, the Customer must:
 - a) place an Order for an Inprogress+ Subscription via the Application and having an active User Account.
 - b) enter the discount code during the Order process in the "Discount code" field.

The free Inprogress+ Subscription is activated in accordance with the rules of the Inprogress+ Subscription service upon placing the Order.

3. After the expiry date, the code becomes invalid.

§ 7

Promotion Limitations

1. One person may not simultaneously use both a paid and a free Inprogress+ Subscription under the Promotion simultaneously or consecutively in a manner that effectively extends the subscription period.
2. The free Inprogress+ Subscription may be:
 - a) transferred to another person,
 - b) used within an organization.
3. The Promotion operates on a multiplicity basis – each paid Inprogress+ Subscription entitles the Customer to receive another discount code (i.e. one paid Subscription = one free Subscription).
4. In the event of Order cancellation or withdrawal from the agreement, any free Inprogress+ Subscriptions obtained under the Promotion shall also be cancelled.
5. The Promotion cannot be combined with other promotions, discounts, or special offers provided by INPROGRESS, unless INPROGRESS decides otherwise.

§ 8

Corporate Orders

1. In the case of Orders placed by organizations:
 - a) discount codes are provided to the person placing the Order,
 - b) that person is responsible for their further use.
2. INPROGRESS allows for individual arrangements regarding settlements and invoicing upon prior agreement.

§ 9

Final Provisions

1. INPROGRESS reserves the right to amend these Terms and Conditions for valid reasons.
2. These Terms and Conditions enter into force on April 7, 2026.
