AgileBA (Agile Business Analyst) is a set of best practices related to business analysis within organizations that have adopted an agile approach to project delivery. AgileBA is based on the processes, roles, and products defined in the **DSDM Agile Project Framework** (DSDM – *Dynamic Systems Development Method*). AgileBA provides guidance that enables effective business analysis throughout the entire project lifecycle. Within this approach, the role of the **Business Analyst** is clearly highlighted, along with their responsibilities and interactions with project stakeholders.

Exam and Certification

- ✓ multiple-choice, single-response questions test,
- ✓ number of questions: 50,
- ✓ pass threshold: 50% (25 out of 50 possible points),
- ✓ language of the exam: English, Polish,
- ✓ duration: 40 minutes,
- ✓ mode: online (after online training) or in-person (after in-person training), / online unsupervised,
- ✓ date: the exam is held at the end of the 2nd day of training,
- ✓ closed book - no use of materials,
- ✓ validity of the certificate: indefinite,
- ✓ the participant who scores the necessary number of points in the exam is awarded the international certificate in electronic form.

When purchasing the exam, the participant may also buy a **retake (Retake Ready)**. In the case of an unsuccessful exam attempt this option allows you to retake the online exam within 12 months from the date of purchase, without paying the full cost of the exam.

The Retake Ready option can be purchased **from Inprogress only when placing an order for the first exam date**. Those who do not take the exam within the 12-month period cannot use the retake option.

The Retake Ready exam is conducted **online** with an **external examiner from APMG**.

Individuals who obtained the AgileBA® certification after 1 May 2017 are eligible for 3 months of free membership with the Agile Business Consortium.
